# FIRST AMENDMENT TO (CORRECTED) AMENDED AND RESTATED CONDITIONS, COVENANTS, RESTRICTIONS AND RESERVATIONS AFFECTING THE RESEARCH TRIANGLE PARK

THIS FIRST AMENDMENT TO (CORRECTED) AMENDED AND RESTATED CONDITIONS, COVENANTS, RESTRICTIONS AND RESERVATIONS AFFECTING THE RESEARCH TRIANGLE PARK ("First Amendment") is made as of the day of October, 2018, by Research Triangle Foundation of North Carolina ("Foundation") for the purpose of amending that certain (Corrected) Amended and Restated Conditions, Covenants, Restrictions and Reservations Affecting the Research Triangle Park ("Covenants") recorded in Book 7559, Page 1, in the Office of the Register of Deeds, Durham County, North Carolina Book, and Book 15768, Page 2175 in the Office of the Register of Deeds, Wake County, North Carolina.

#### BACKGROUND:

The Foundation desires hereby to amend the Covenants as hereinafter set forth. The Research Triangle Park Owners and Tenants Association, an unincorporated association ("Association"), approved this First Amendment by a favorable vote of at least a majority of the votes cast, as required by Article X, Section 4.1 of the Covenants, at a meeting of its members held on October 1, 2018, duly called for the purpose of considering this First Amendment.

NOW, THEREFORE, the Foundation, with the favorable votes of a majority of the Association, hereby amends the Covenants as follows.

- 1) In Article VI, Section 1, a new paragraph labeled "(h1)" is inserted between existing paragraphs (h) and (i), which new paragraph (h1) reads as follows:
  - (h1) Facilities used for primary or secondary public education purposes provided the Tract upon which such facilities are constructed (i) is zoned for primary or secondary public education uses; (ii) is not immediately adjacent to any other Tract within the Research Triangle Park which is not also used or held for primary or secondary public education purposes; and (iii) is adjacent to land that is not part of the Research Triangle Park.
- 2) The last sentence of the first paragraph of Section 2 of Article VI is hereby deleted in its entirety and the following new sentence is hereby substituted:

Except for primary or secondary public education uses permitted pursuant to subsection (h1) of Article VI, Section 1 above, primary and secondary education uses must be in a district reserved for mixed use or commercial uses.


